Bid Documents for the above tenders will be available on **Monday, 11 January 2016** at **Mopani South East TVET College, Corporate Centre, Cnr Combretum & Haarlem, Phalaborwa.**

Preferential Procurement Policy Framework Act No. 5 of 2011 of the Supply Chain Management Policy, of Mopani South East TVET College will apply in the adjudication process. The evaluation of the acceptable bid will be conducted in the following two stages:

- Firstly, the assessment of functionality will be done in terms of the evaluation criteria. A bidder who scores less than 60 out of 100 for functionality will be regarded as non-responsive bid and will be disqualified.
- Thereafter by using a system that awards points on the basis of **80 points proposals price and 20 points (below 1 Million Rand) OR 90 points proposal price and 10 points (above 1 Million Rand)** for B-BBEE status level of contribution.

Bidders must submit verification certificates that are accredited by SANAS (South Africa National Accredited System) and IRBA (Independent Regulatory Board of Auditors). Points will be awarded to a tenderer for attaining the B-BBEE status level of contributor in accordance with the table below:

A trust, consortium or joint venture must obtain and submit a consolidated B-BBEE Status Level Verification Certificate with their tenders.
