Preferential Procurement Policy Framework Act No. 5 of 2011 of the Supply Chain Management Policy, of Mopani South East TVET College will apply in the adjudication process. The evaluation of the acceptable bid will be conducted in the following two phases:

- **Phase 1 – Compliance:** The phase refers to all the required returnable documents. A Bidder compliant to this phase will proceed to phase 2.
- **Phase 2 – Technical/Functional Evaluation:** Functionality is worth hundred (100) points. Bidders who score less than seventy (70) points on functionality will be disqualified. Only Bidders who score seventy (70) points or more will be required to submit a detailed financial proposal in line with the Supply Chain Management Policy of the College.

Bidders must submit verification certificates that are accredited by SANAS (South Africa National Accredited System) and IRBA (Independent Regulatory Board of Auditors). Points will be awarded to a tenderer for attaining the B-BBEE status level of contributor in accordance with the table below:
