## **OFFER AND SPECIAL CONDITIONS:**

All tenders submitted in reply to this invitation to tender should incorporate all the forms, parts, certificates and other documentation forming part of this invitation to tender, duly completed where required. Each page should be initialed with a black pen. Failure to comply with this will lead to disqualification.

Preferential Procurement Policy Framework Act No. 5 of 2017 of the Supply Chain Management Policy, of Mopani South East TVET College will apply in the adjudication process. The evaluation of the acceptable bid will be conducted in the following two stages:

- Stage 1: Functional/Technical Evaluation Functionality is worth hundred (100) points. Bidders who score less than seventy (70) points on functionality will be disqualified and not proceed to stage 2.
- Stage 2: Evaluation in terms of Preference Point System Each Bidder that obtains the minimum qualifying score for functionality will be
  evaluated further in terms of price and the preference point system. (80 Points Proposal Price and 20 Points for B-BBEE status level of
  contribution Rand value equal to or above R 30 000.00 and up to R 50 million)

Bidders must submit verification certificates that are accredited by SANAS (South Africa National Accredited System) and IRBA (Independent Regulatory Board of Auditors). Points will be awarded to a tenderer for attaining the BBBEE status level of contributor in accordance with the table:

A trust, consortium or joint venture must obtain and submit a consolidated B-BBEE Status Level Verification Certificate with their tenders.

**Tenders should note the following:** • Tenderers who are listed in the National Treasury register of defaulters will automatically be disqualified • It is compulsory to complete all the applicable SBD forms which are attached as returnable documents.

No corrections may be made with correction fluid, such as Tipp-Ex or similar products. If a mistake has been made, it should be struck out once in a black ink and the same person who formally signed the tender must sign in full at every correction made. The College reserves the right to reject a tender if any corrections are not made in the manner set out above.
